INTRODUCTION

The Project

In 2019, in response to a community petition, Council endorsed the preparation of **Phase 1**: Design Opportunities and Considerations Report to investigate rehabilitate and revegetate the Kent Street Sand Pit. The project aims to direct the future management of the reserve, restoring the natural environment and enhancing the community connections to the space.

The site is zoned for parks and recreation under the Metropolitan Region Scheme (MRS) and, due to the sites' history as a landfill site, is classified as 'remediated for restricted use' under the Contaminated Sites Act 2003. These considerations limit the options for redevelopment of the site. Fortunately, the previous decisions of the Town of Victoria Park Council, consultation with the Town of Victoria Park representatives and key local stakeholder strongly indicated a preference for the establishment of a relatively informal, conservation-oriented area of public open space within the site.

The Phase 1 report scoped the various considerations, constraints and subsequent opportunities that exist for the site, namely utilising the site for passive recreational and cultural purposes, with revegetation being a strong focus and creating a significant amenity for the Town's community and visitors.

Phase 2 seeked to develop Concept Plans for the Kent Street Sand Pit site which guide the design direction of natural spaces in this urban area in an economically realistic, respectful of the natural environmental values and maximising the value and opportunity that community connection to natural spaces provides. The end of Phase 2 resulted in one concept option adopted


Phase 3 seeked to produce the Detailed Design package based on the endorsed concept plan from Phase 2.

To enable the detailed design to evolve, a community consultation strategy was programmed. This included:

- Stakeholder engagement of the Mindeera Advisory Group, Traditional Owners, UFS Working Group, Friends of Jindarup Bushland, Town of Vic Park Staff and community.
- Digital engagement through the Town of Victoria Parks 'Your Thoughts' platform closed 6 February 2023.

The following document outlines the outcomes of the consultation, the Town of Victoria Park responses and the impacts on design.





If not in support, let us know why:

- I am concerned about the possible anti social environment this will encourage
- It's pretty underwhelming and more of the same as what's available in the rest of the bushland precinct. There is nothing outstanding in the design that connects it to the place
- The council deliberately constructed the review and consultation process to enable it to propose and approve one single use consideration without any due to respect to the broader community wishes. Yes of course the council will consider they did - but the process never gave any consideration for use of the site as a community open access area/sporting groups. The single focus on The Bushland proposal satisfies a handful of birdwatcher
- This appears to be a massive waste of money for something that will not be used. Even if it is used, traffic on Kent street will increase which puts a risk

on the children at the school.

We do not want an increase of anti-social behaviour. (as in Harold Rossiter Park)

Surely there's a better way to use this money. Or lower our rates.

- The area should be reinstated as native bushland similar to the Kensington Bushland. Infrastructure should be limited to paths and benches
- · Viewing platforms, increased visitors to area of real concern. Especially as we look onto this quiet area apart from its usual bird life
- I believe there is an opportunity here that could include a off road/track for mountain bikes. There is a few pump tracks in the suburbs that get very busy, but no natural terrain trails in the suburbs. These would be cheap to build and would require next to no upkeep

- Details of the accessible wheelchair points. Response: As above.
- Tactile ground surface indicators proposed for each ramp. Response: As above.
- Compliance of the shared space beside ACROD bay? Response: As above.
- Consideration should be given to making the paths 3mtrs wide with an access ramp for 4wd ambulance or fire appliances. Response: Advice from bushfire consultants informed the design, the site, the 3m perimeter path will be sufficient for mobilisation around the sand pit.

FLORA



CONSIDERED

- Indigenous vegetation should be restored. Response: Noted. This will be informed by the 5 star restoration project.
- Increase shade tree canopy. The sand pit and the surrounding bushland is extremely hot at times and uncomfortable do to a lack of large shady trees. Response: Noted. The intent of the site will be to restore to Banksia Woodland, which will increase canopy. The aim is to contribute to the Town's urban forest, including canopy, which will provide shade. It may be take some time for these trees to establish.
- Planting Eucalyptus and Acacias. Response: Noted. This will be informed by the 5 star restoration project.
- The design should privilege restoration over infrastructure. Response: The main intention of the site is to restore Banksia Woodland. Approximately 90% of the site will be revegetated. The remaining infrastructure is to allow our community to easily access the site, interact with the bushland, as well as experience cultural exchange opportunities
- Placing major importance on re-vegetating the land for the benefit of black cockatoos. This will be programmed on Harold Rossiter Park outside of the project area. Response: The Town is working with the Curtin University restoration team. As part of this, provision of faunal habitat, inclusive of Black Cockatoos, is a key focus.

NOT CONSIDERED

 Planting Macadamia trees to provide an alternate food source for the black cockatoos. Response: Noted. This will be programmed on Harold Rossiter Park outside of the project area.

PLAY | RECREATION | DOGS



NOT CONSIDERED

- Off road cycle track. Response: The classification of the site precludes the Town from large impermeable surfaces or active recreation on the site.
- Fixed exercise equipment. Response: Exercise equipment may be better explored at Harold Rossiter Reserve.
- Attraction for young families, opportunities for kids to engage with the bushland. Nature play area/nature walkway for kids to play, sit and have a picnic as well as going for a walk. Response: Some nature play elements may be incorporated into the precinct.
- Incorporation of a fenced off part of the space for people to exercise dogs. Response: The use potentially conflicts with the intended restoration of flora and fauna on the site.
- Make it a dog friendly area. Provide dog waste bags at bin locations. Response: Given the intent of the site, dogs are welcome but would need to be leaded.

MATERIAL | FURNITURE | FACILITIES

CONSIDERED



- Consideration of a different material than timber for the deck. Metal grating that is accessibility Response: Noted. The materiality of the decking will be revised.
- Drink fountain at the Baron-Hay entrance. Water bottle drink station/bubbler by the car park. Response: It will be considered for Baron-Hay entrance. drinking fountain at the car park has been included.
- Bins. Response: It has been included in the carpark and at the Baron-Hay entrance.
- The precinct (including the sand pit) would benefit from formalised shaded areas for sitting and the site. The aim is also for the site to significantly contribute to the Town's urban forest, including canopy, which will provide shade.

FUTURE CONSIDERATION

 Details of what backrests and seat arms are available on the seating at each of the resting points. Response: This will be determined through documentation.

NOT CONSIDERED

- Storage spots / tubs / areas for any community group to store or remove rubbish. Response: Noted.
- Off the path shelters with seating/table. Response: There are some seating areas. Picnic areas were explored but then removed because of the potential rubbish and food waste risk.
- Raise the height of viewing platform. Response: These cannot be too high as the height needs to be access.
- Public toilet facilities would make it more accessible for families as well as shaded picnic tables. as public toilets. Public toilets are available at Harold Rossiter building.
- Could you consider making the paths out of the same finish as the Kensington Bush land? The whiteness of the path is much cooler and more pleasant to be on in summer. Response: The path material considered is a sealed clay-aggregate, similar to that within Hillview Bushland. This was chosen for maintenance requirements. It is also best for restoration efforts.
- Barbecues & gazebos like at Burswood. Response: Picnic areas were explored but then removed because of the potential rubbish and food waste risk. These facilities are available in Harold Rossiter Park.

There are education/knowledge exchange nodes indicated on the design. This will include environment education as well as cultural education, storytelling.

• A plan of all parking available including number of proposed bays. Response: *The Detailed* Design shows the entry parking.

FUTURE CONSIDERATION

- Including the development into learning topics or excursions for local schools. Response: Integrated into the site will be environmental and cultural education. As such, we would hope that schools will visit the site, and are happy to liaise with schools to have visitation considered.
- Give the community the opportunity to participate in plantings. Response: It is anticipated that this will be coordinated as part of the Urban Forest Community Planting Day series.
- Plans for regulation of ages, events... Regular timeslots for activities to be set out. Response: This will be considered as part of future operation of the site.
- All vistas need to be open most times for everyone's pleasure and entertainment. Response: This will be considered as part of future operation of the site, including site security.

NOT CONSIDERED

- Is there a way to connect the Kensington Bush Land to the sandpit? It would allow a larger variety of walking options. Response: The Town is trying to minimise the amount of Bush Forever vegetation that may be disturbed as a result of pathway installation. For that reason, only one pathway (Etwell St) is proposed to allow direct connection between the Kensington Bushland entry and that of the Sand Pit.
- Parking in Baron Hay court needs to be considered. Response: Street parking is outside the scope of this project, but will be considered as part of the broader precinct.



STAGING AND DELIVERY

The Project

The staging and delivery of works within the site will be well informed by the recently instigated George Street Reserve Revegetation Project on the north eastern side of the Jindarup Bushland Precinct. With the progression of the Kent Street Sand Pit detailed design a recommended general staging of works is as follows:

- 1. Landscape plan preparation including community consultation (external consultants / Town).
- 2. Detailed design.
- 3. Documentation preparation (external consultants).
- 4. Tender works for construction of the parking area and paths and features (Town).
- 5. Construct parking area, paths and features (external contractor).
- 6. Tender or coordinate progressive works for planting of restoration areas (external contractor / Town).
- 7. Complete progressive works within restoration areas (external contractor / Town).
- 8. Ongoing maintenance of infrastructure and restoration areas (Town).
