

Town of Victoria Park - Local Planning Scheme No.2 Register of Non-Conforming Uses

Clause 24 of the Town of Victoria Park's draft Local Planning Scheme No.2 (draft LPS2) provides for the local government to prepare a register of land within the scheme area that is being used for a non-conforming use.

As per Clauses 22 of draft LPS2 a non-conforming use is for land that has been lawfully used in the past, however due to subsequent changes in zoning or land use permissibility's under the scheme, would now be a prohibited land use and incapable of receiving development approval.

The scheme cannot prevent the continued use of land for a non-conforming use unless a period of at least 6 months, or a longer period approved by the local government, has elapsed since the discontinuance of the non-conforming use.

As per Clauses 23 of draft LPS2 a non-conforming use cannot be altered or extended without development approval.

The following table is the Town of Victoria Park's, Register of Non-Conforming Uses and is prepared in accordance with and is subject to Clause 24 of draft LPS2.
