The Lathlain Place entry to Oval 1 is closed on game days, so the spectators have become frustrated as they have to continue around to the Goddard St entrance. The spectators have no consideration for the rights of residents and park across their driveways or on their verges. The lack of available parking for the patrons of the businesses and community facilities on Lathlain Place and Gallipoli St must be affecting their customers.</p> <p>There has been significant increases in the number of businesses and community facilities in Lathlain Place which require parking for their customers, but the parking availability has significantly decreased since the WCE facility was constructed.</p> <p>There is no consistency with the traffic management plan in operation on game/event days - there was temporary traffic lights used (but ignored by the road users), a section of Goddard Street closed and on another occasion only reduction in speed along this section of Goddard St..</p> <p>The parking signage is outdated - it has not been updated since the Lathlain Station existed at the bottom of Goddard St/Rutland Ave corner and the games were played on Saturday, Sunday and Public Holidays from March to Sept each year. The games are now played on Thurs and Friday nights mainly because of the availability of the lighting towers.</p> <p>There are now three football club playing at the facility and from 2024 this will increase to four.</p> <p>The road network has had traffic calming added since the WCE was constructed and the streets have been reduced capacity for parking.,</p>	Strongly support
