ABORIGINAL LAND SOVEREIGNTY NEVER CEDED THIS PARK SHOULD BE RENAMED FOR THE LOCAL WAJUK

I think a lot of people currently don't know the name of this house or park. Going from Edward Millen to Elizabeth Baillie will not stick in people's minds either. I think using one name instead of two is easier for people to say and hence remember. Maybe Elizabeth Baillie House is suitable for the historic building but the park should be named something different. Even just Baillie Park would be better.

I'm not a fan of naming places after individual people. In all areas of life, achievement is a team effort. Hence, naming something after one person 'heroes' the individual at the expense of the team. In regard to this property, I support the move to remove the name of Edward Millen, whose claim to fame in this instance is dubious. But it should not be named after the hospital's founder either, as the adjoining street (Baillie Ave) is already named after her, which should be sufficient.

Good to remove the Millen name form this place. Im unsure about renaming to Bailey as she already has her name commemorated. An Aboriginal name may be better to reflect todays forward thinking. Could combine Bailey with a Noongar name for pregant or birthing such as Boodjari Bailey - would need Elders support and linguists spelling/naming

What are your concerns?

I support the change of name for the building to Elizabeth Baillie House as her foresight and contribution to the community should be recognised.

I would prefer if the name of the park remained as it also gives an indication of the history and uses of the site.

Why change it. Everyone knew its name.

The name for the buildings are entrenched in the community...my family have lived in VP & EVP since 1916 and when ever I have talked to my elders that is how it has been identified ...almost 100yrs as Edward Millen...it will be a shame to lose that link to our oral heritage just for the sake of change. I think a compromise would be better

Just feel its change for changes sake. I'd rather you focused on preserving the actual park and building. You are going to alienate the building more than it already is by changing the name.

Baillie has a street named after her. Both should be recognised. Rename the street to Edward millen parade but recognise both contributors.

No concerns, just a preference

Why isn't Edward Mullen significant enough for the TOVP to keep his name there.

While I like the sentiment in naming the area after Elizabeth Baillie, I disagree with using her full name. The name isn't memorable nor does it reflect the nature of the space. I suggest just naming the area Baillie, or Baillie Park.

I would like to also see a dual Noongar name for the place.

The correct heritage name is Rotunda.

Given the fact that the location has borne the Millen name since 1924, if we wish to honour Elizabeth Baillie then might it not be better to rename it Millen-Baillie House and Millen - Baillie Park to recognise both of these important members of our community. This way the heritage remains on a property that has carried one name for almost 100 years.

The name change does not reflect that the land was and always will be Aboriginal land. Instead it heroes colonisation.

just think maybe you could keep some love for old Eddie… maybe "Baillie-Millen Park" or similar? Why the need? Too many Wokes. Perhaps if anything the park could be named after Elizabeth Baillie but not the actual building as most locals know it as Edward Millen.

I am supportive of the decision to rename the building and park to honour Elizabeth. But I feel like the Town is missing out on a key opportunity to acknowledge the first peoples of this land.

I think the town should look to other cultural precincts like Goolugatup Heathcote who are honouring both the European and Aboriginal history of their location.

The name for the park and building could have a dual name like Mindeera Baillie House.

The town should look to consult with the Mindeera Advisory Group and bring in external consultants like Moodjar Consultancy to decode place names in the area.

Definitely support naming the house for Elizabeth Baillie, I'm a midwife so this is amazing recognition for a founder of the profession in WA. I wonder though if we can give the park a name to reflect our Whadjuk Noongar heritage instead, an acknowledgement that the house and then the ongoing use of the land is still tied to our First Nation people. It seems to me that both sites don't need to be named the same. I hope this can be considered.

I think it is important to balance the naming of places to remember the more excluded groups. I love this idea and support it fully.

I think it would be nice to honor both people...please consider leaving the buildings as Edward Millen and changing the park to Elizabeth Baillie

i think it should be Elizabeth house, in reference to Elizabeth Baillee, not both names as they are a cumbersome and unappealing way for naming places. The reference should be explained in a plaque on the premises.

Elizabeth Baillie House is a better reflection of its history as a women's maternity hospital and the woman who founded it. I had also heard that this area may have been a site for Aboriginal women to give birth prior to colonisation. If this is the case, it could be more powerful to acknowledge the much more ancient history of the site as a place of women's business with an Aboriginal name. But i'm happy enough to know that the site would be renamed after the Maternity Hospital's founder. Renaming will give it a fresh start for a new range of uses.

Great idea, it has a link to the past and not a previous politicians name.

Elizabeth Baillie's contribution to the advancement of obstetric care in Perth should be recognised via the re-naming of this site. Being an educated woman operating a hospital in the early 1900s, she would appear to have been something of a trailblazer, and therefore more worthy (in my opinion) of recognition than a government Minister who no doubt received ample recognition and remuneration for his work at the time.

Aboriginal land sovereignty never ceded this park should be renamed for the local Wajuk Fantastic initiative!

Maybe the park should remain as "Edward Millen Park" to acknowledge his contribution to the Town. My grandmother and her new born baby died in Edward Millen house of Spanish Flu in 1919 leaving 8

children including my mother who was 2yrs.

I support the name change away from Edward Millen and appreciate the suggestion of Elizabeth Baillie. However I would hope some consultation was made which led to the suggestion, especially considering the land may have had a previous Indigenous title or association as well. Perhaps naming the building after Elizabeth and the park something else with a local Aboriginal reference would be more appropriate?

On reading the information provided, I believe that Elizabeth Baillie House and Park better reflect the history of the precinct.
