Purpose of the item

At the November Lathlain Park Advisory Group Meeting, the ongoing suitability of the Terms of Reference was raised. This item will provide a chance for review and discussion by the group itself.

The Term of the group is stated until the endorsement by Council of concept design. However, given the development potential of the site's southern portion, this context has been questioned.
