<p>The club currently lacks sufficient equipment to provide adequate training opportunities for their members, this also limits the number of new members they can take on.</p> <p>They are planning to purchase uniforms, basic training equipment, safety/first aid equipment and supplies.</p>			

Panel Assessment:

- The equipment will help represent and attract females into Australian Football League Women's.
- This grant assists a niche area i.e., older participants in a male dominated sport.
- Good mix of equipment including first aid kits.

<p>The club is requesting replacement of old equipment for the new season. This will encourage a stronger sense of club culture on game day by providing the 2022 Curtin Panthers squad with winter water-resistant jackets to wear on game day and to and from training.</p> <p>The purpose of the jackets are as follows:</p> <ul style="list-style-type: none"> • To provide a weather appropriate team uniform to all club members. Association level netball is a winter sport, and they regularly play in heavy rain and wind throughout the season. • To increase visible branding of the club on game day • To encourage a stronger sense of the Curtin Panthers club culture. 			

Panel Assessment:

- The grant will be for uniforms and new equipment promoting fitness in the cooler months.
- Strong explanation provided to justify the purchase of the equipment.
- List of items to purchase is well, thought out and considered.

<p>The club is requesting to purchase squash balls, grips, coach shirts and coaching equipment.</p> <p>The squash balls are to be used for beginners, juniors and their pennant players to help with training/coaching and provide a service to the club.</p> <p>Due to the high temperature at the Squash Centre the balls are not lasting as long, requiring more to be purchased.</p> <p>The over grips are for the racquets which they loan out to juniors and new players joining the club. Especially with COVID this is a necessary requirement to frequently change the grips.</p> <p>The coach shirts will help the squash community identify coaches within their club and junior program.</p>			

Panel Assessment:

- Funding will replace squash balls that are used for beginners, juniors and their pennant players.
- Funding will replace, old worn parts of the equipment so that the equipment can be loaned to junior player and new players.
- Club is located within the Town at Leisurelife Centre.

<p>Dynamic Flame Badminton Club are requesting funding for new badminton racquets.</p> <p>The racquets are necessary for the following reasons:</p> <ul style="list-style-type: none"> • The racquets are essential to play badminton and to provide and service the increasing number of players from the Town of Victoria Park, more racquets are required • The Racquets are guaranteed to last two years and will enable the club to sustain and grow the program • The racquets will also be used at "Come try Badminton Days" and Mini "Open Social Badminton Days" • The provision of racquets will also assist our volunteers to continue conducting the sessions under less stress and pressure because of availability of equipment • Racquets will be used in competitions. 		

Panel Assessment:

- Quote provided for Racquets; I recommend funding of \$500
- Provided five reasons why Racquets are required. Essentially, they need more Racquets to meet demand
- They are a local club and expanding

<p>Funding is requested for new sports equipment, uniforms, balls, goals, and training equipment.</p> <p>The club is going through a period of transition, and they require new equipment. By refreshing their equipment, it will help sustain their current membership levels as well as attract new members within the local area.</p>			

Panel Assessment:

- A good application with a clear explanation of equipment being purchased. Detailed list and pricing of equipment provided.
- Club is going through a period of transition. A significant amount of equipment requires refreshing, with some equipment out of date.

Please note: The Town recommended the above Sport Equipment Grant to be endorsed for \$500 and another \$487.50, for the fridge component at the 16 November 2021, Ordinary Council Meeting, Point 12.9 – Vic Park Funding Program – Arts, Community, Sports and Sports Equipment.

There was an Amendment endorsed at the Ordinary Council Meeting, that Point 5c of the Officer's recommendation be deleted. This amendment only referred to the fridge component of the sport equipment grant. See amendment below:

Reason:

"A fridge is not sporting equipment, as it is not necessary for, or related to, the playing of football, nor is it needed for maintaining the club's equipment. It is related to the recreational and revenue raising activities of the club, and it sets a precedent to encourage other sporting clubs to consider grant funding for similar items".

Council did not endorse the \$500 amount for the sport equipment requested for Perth Royals Football Club Inc. at Ordinary Council Meeting on 16 November 2021, hence the application being provided again for consideration for the related / eligible, sporting equipment.
