The proposal has been considered in the context of the identified cultural heritage significance of *Edward Millen Home (fmr)* and the following advice is given:

## **Findings**

- The referral is for the proposed demolition of the former Hillview Clinic building. The building is a single storey brick and tile structure which is currently unoccupied. The purpose of the demolition is to allow for the future redevelopment of the Edward Millen Precinct.
- Edward Millen Home (fmr) has cultural heritage significance as a place that
  makes a contribution to the sense of place of those who have had
  associations with the place as a maternity hospital, sanatorium, psychiatric
  clinic and centre for autism. Through an understanding of the buildings and

- landscape elements, the place has the potential to illustrate various aspects of the development of health care in Western Australia from 1912 to 1997.
- The trees surrounding the fmr Hillvew Clinic that have been identified as considerable significance in the 2001 Conservation Plan should be retained. It has been confirmed with Town of Victoria Park Strategic Projects Manager that the trees referenced for removal will not be removed as part of this referral and may be included in a future referral.
- The proposed demolition works could physically impact on adjacent buildings and potentially cause damage. As a precaution, a program of monitoring any structural movement and potential vibration impacts should be implemented at the commencement of works.

## **Advice**

The proposal, in accordance with the plans submitted, is supported subject to the following conditions:

- 1. The trees identified as considerable and some significance in the 2001 conservation plan shall be retained. It is noted that their removal is not part of this development referral.
- 2. Prior to demolition, a photographic archival record of the former Hillview Clinic (Block C) shall be prepared in accordance with the Guide to Preparing an Archival Record (attached). A copy shall be provided to the Heritage Council for its records.
- 3. A program of monitoring any structural movement and potential vibration impacts on adjacent buildings (Rotunda/Edward Millen House and Former Ward Block) shall be implemented at the commencement of works. The Heritage Council is to be notified immediately if any impact occurs and advised on a recommended course of action by a suitably qualified structural engineer.

Please be reminded that you are required under r.42(3) of the *Heritage Regulations* 2019 to provide us with a copy of your determination within 10 days after making the decision.
