**Petition of Electors**

To the Mayor of the Town of Victoria Park,

We, the undersigned, all being electors of the Town of Victoria Park do respectfully request that Council:

Initiate a trial to upgrade footpath lighting for pedestrians to improve safety and reduce anti-social behaviour, whilst maintaining and encouraging existing tree canopy, in the following Old Burswood Neighbourhood Watch streets;

1. Clydesdale Street, between Teague Street and Kitchener Avenue,
- and
2. Duncan Street, between Shepperton Road and Kitchener Avenue

The reasons for this request are:

1. Night time lighting levels over footpaths in these two streets are very low and in some areas non-existent. This creates potential trip hazards and other safety issues for pedestrians.
2. It is difficult to observe or detect persons moving through these low lighting areas, which encourages antisocial behaviours and criminal actions that cannot be witnessed or captured on CCTV.
3. Residents of these streets and surrounding areas believe the low lighting levels specifically encourage antisocial behaviour and criminal behaviours.
4. The recent Old Burswood Neighbourhood Watch Group's lighting levels survey of Burswood and Victoria Park highlighted these two streets as being "dark spots" with regards to footpath illumination levels.  
Note; Street lighting is specifically provided to illuminate roadways.
