COVID-19 Action Plan – Working Plan

CRWG members received a presentation on the COVID-19 Action Plan – Working Plan which included a status update on recovery planning, existing business support measures, data sets being used to track the local economy and the development of the COVID-19 Action Plan.

The following discussion took place:

- Quotes for an Impact and Opportunity Assessment have been sourced from various businesses including local businesses and larger organisations. The successful vendor will be asked to provide an assessment on the damage and opportunities that COVID has brought to the local economy.
- The Economic Recovery Taskforce have been monitoring local economy datasets including parking occupancy rates and pedestrian footfall numbers. Pedestrian counters are located in Victoria Park and East Victoria Park and pick up people walking underneath. Cyclists and vehicles are not included in the counts.
