Purpose of the item

To inform the working group of the financial considerations of the Town and how this may impact the funding of the program in 2023/2024 financial year.

- 2. UFS to build a capital component of \$380,00 (left in the reserves) meaning almost 50% reduction planting and labour ect
- 3. This does not impact on the operating expense ect Comm, Education, events and staff.
- 4. This budget not coming out of UFS 3 long term significant projects.
 - a) METRONET large scale urban ecosystem planting and canopy cover
 - b) Kent St sandpit large ecosystem 5 star restoration project
 - c) Causeway pedestrians bridge
- 5. How are we going to approach reallocation of budget continue with tree planting and remaining budget to projects. To meet the strategic outcomes of the Strategy
- 6. While we must have a full program designed and project ready much better at seeking external funds.

Q - Cr Lisandro does this impact green basins/micro parks and final impacts implementation biophilic design.

A: Green basins will not go ahead this financial year, can be budget for next financial year. We will not be cutting back on delivery of education or community engagement.

Q - Cr Lisandro: How is the street planting on verge affected, what is the budget

A: The street tree budget allocation would be maintained

DD: We are needing to look at the ongoing care of the projects and our ability to resource.

As funding has not been confirmed for the next financial year DB will be developing both a full program along with the reduced version, develop a long-term program plan reflecting the budget allocation and strategic priorities.
