- Forward Reserve (part of POSS Better Parks Sub-Program) Complete
- Kent Street Sand Pit (site prep)
- Bus Stop Thankyou Garden Mackie Street Contractor early September
- Ecozoning Carlisle Reserve, Harold Rossiter, Fraser Park Procurement is in progress
